In compliance of, our many State Units and Affiliates had submitted memoranda in their constituencies.

19<sup>th</sup> July is a Historic day when first fourteen Scheduled Commercial Banks were Nationalized in 1969 by the then Prime Minister Late Mrs. Indira Gandhi, who was spearheading the Government of that time. Our Confederation thought it fit to submit a detailed representation / memorandum to Smt. Sonia Gandhi, President of Indian National Congress, the largest opposition party, on that historic day.
